REPORT

QUALITY MANAGEMENT/ PROVIDER SURVEY UPDATE

Lisa Nugent read an update provided by David Cavalleri, the Quality Management consultant, on the provider survey. So far, the survey has had a low response, with only 5 respondents. Dorinda and Lisa Cohen suggested that the survey be sent out to more providers and volunteered to help David get the names and email addresses of their contacts.

The QM workgroup met via conference call in December. Steve Palermo gave an overview of the conference call where the group discussed the Affordable Care Act and their progress over the last year and objectives for 2014. The next QM workgroup meeting will be January 17, 2014.

AFFORDABLE CARE ACT IMPACT

Members discussed the impacts of the Affordable Care Act they were seeing with their clients. Members noted that clients are scared of the changes and uncertainty surrounding the ACA. Much is still unclear about what the Ryan White system will be able to assist with in terms of co-pays and premium assistance. The State of Florida is slow at giving direction to the Part B's. Ryan White remains a payer of last resort. Members reported that it seems to be the people who would have been helped by Medicaid expansion who are having the most troubles. Those who are in the marketplace and getting subsidies seem happy.

ANNOUNCEMENTS/ COMMUNITY CONCERNS

Members shared information about the rebuilding of the AIDS Memorial Park in Tampa. The information will be shared via Info Share when it is out.

PAC Waiver is short on funds and has therefore gone to a waiting list for all clients wanting to enroll in Florida. They are assessing if lifetime eligibility should continue and other possible solutions.

The committee thanked Lisa Cohen for her 35 years of service.
